BODY OF REPORT:

AT APPROXIMATELY 2200 HOURS I RECEIVED A CALL TO REMINGTON PARK IN REFERENCE TO A DISTURBANCE. ONCE I ARRIVED ON THE THIRD FLOOR, I WAS BRIEFED BY SECURITY THAT ADVISED ME THEY HAD PEOPLE DETAINED AND SEPARATED IN REFERENCE TO AN ASSAULT. SEE CASE NUMBER 08-54128.

THEY ALSO HAD A POSSIBLE VICTIM OF A SEXUAL ASSAULT. I MADE CONTACT WITH VI [REDACTED] WHO WAS TALKING TO EMT STAFF FROM REMINGTON PARK. I GAVE MEDICAL STAFF A FEW MINUTES. AT APPROXIMATELY 2210 HOURS I BEGAN SPEAKING WITH VI [REDACTED] I ASKED VI WHAT HAD HAPPENED TONIGHT. VI BEGAN TO CRY. I ATTEMPTED TO CALM HER

TELLING HER THAT THERE WAS NOTHING SHE COULD POSSIBLY TELL ME THAT IN MY 10 YEARS EXPERIENCE THAT I HADN'T HEARD FAR WORSE.

VI STARTED OUT SAYING SHE HAD BEEN DRINKING AND HAD DRANK AT LEAST THREE GLASSES OF WINE. VI STATED SHE IS NOT ACCUSTOMED TO DRINKING ALL OF THE TIME. SHE STATED THAT DURING THE NIGHT AT THIS WEDDING RECEPTION SHE HAD BEEN TALKING TO A RETIRED OFFICER, BUT DIDN'T KNOW HIS NAME. VI STATED THIS SUBJECT WAS BEING A GENTLEMAN. I ASKED HER IF THERE WAS ANYTHING ELSE SHE WANTED TO TELL ME THAT MIGHT HAVE HAPPENED TONIGHT.

VI HESITATED, BEGAN CRYING AGAIN, AND SAID, "HE'S THE PRESIDENT OF THE BAR ASSOCIATION." I ASKED HER IF SHE KNEW HIS NAME AND SHE SAID NO. IT WAS OBVIOUS THAT VI WAS HESITANT TO TELL THIS OFFICER THE INFORMATION, SO I WAS PATIENT GIVING HER PLENTY OF TIME. VI THEN SAID THAT THIS SUBJECT, LATER IDENTIFIED AS AR, WANTED TO SHOW THE VI HIS OTHER SUITE #3. IT SHOULD BE NOTED THAT THE RECEPTION WAS IN SUITE 6.

VI AGREED. ONCE INSIDE THE SUITE, SHE REALIZED THERE WAS NO ONE IN THERE BUT HER AND AR. AR ASKED VI, "ARE YOU A TEASE LIKE ALL THE OTHER WOMEN?" AT THIS POINT, VI STATED AR PULLED DOWN HER TOP AND BIT VI'S NIPPLE ON HER BREAST. IT SHOULD BE NOTED VI WAS WEARING A BLACK STRAPLESS TOP MAKING IT VERY EASY TO BE PULLED DOWN. VI TOLD ME AT THIS POINT, SHE STATED TO AR, "I NEED TO LEAVE." AR BEGAN BLOCKING VI'S PATH AND CORNERING HER.

VI SAID SHE TRIED TO GET AROUND HIM. HE GRABBED HER BY THE HAIR AND BIT HER ON THE BACK OF THE NECK. I OBSERVED SOME RED MARKS ON THE BACK OF HER NECK APPROXIMATELY 2-3 INCHES LONG. VI STATED AT THIS POINT, "HE GRABBED MY PUSSY." I ASKED VI IF HIS HANDS WERE INSIDE HER PANTS OR OUTSIDE. VI SAID, "OUTSIDE." IT SHOULD BE NOTED VI WAS WEARING WHITE CAPRI PANTS. VI WAS STILL CRYING AND SAID, "BUT HE DIDN'T RAPE ME." I ASKED HER WHAT SHE MEANT BY THAT. SHE SAID, "HE DIDN'T GET ANY FURTHER THAN GRABBING MY PUSSY."

I ASKED HER HOW MANY TIMES SHE TOLD AR THAT SHE WANTED TO LEAVE. SHE SAID AT LEAST TWICE AFTER THE INITIAL REQUEST TO LEAVE. I ASKED VI TO DESCRIBE AR, WHO AT THE TIME WAS THOUGHT TO HAVE LEFT. VI STATED HE WAS OLD WITH GRAY HAIR, PRESIDENT OF THE BAR ASSOCIATION, WAS CHUNKY, HAD NO FACIAL HAIR, CLEAN CUT, WEARING A WHITE POLO, AND WAS NOT WEARING A WEDDING RING. HE ALSO SAID THAT HE WAS DIVORCED. AR HAD TOLD VI THAT HE WAS PART OWNER OF SUITE 3 AND 6. A SHORT TIME LATER, I HAD ASKED SPRINGLAKE AIR FOR MORE UNITS TO HELP ME WITH THIS CALL AND ON THE RELATED CASE NUMBER 08-54128.

SGT. SELLARS, #1367, SGT. EASTRIDGE, #1456, OFC. BULLARD, 1636, AND MY SUPERVISOR, LT. MILLER, #1013 WAS CALLED TO ASSIST AND THEY ARRIVED ON SCENE.

DURING MY BRIEFING OF THE FELLOW OFFICERS, A SECURITY GUARD APPROACHED ME AND SAID THE FELLOW THAT I BELIEVE YOU MIGHT BE LOOKING FOR IS IN THE BATHROOM. I LOCATED AR MURDOCK IN THE RESTROOM. I ASKED HIM WHEN HE WAS FINISHED IF HE WOULD COME OUT AND TALK TO ME. AR MURDOCK AGREED. I HAD HIM SIT IN A CHAIR UNHANDCUFFED BECAUSE HE WAS NOT IN CUSTODY.

SGT. SELLARS, OFC. BULLARD, AND SGT. EASTRIDGE BEGAN TO INTERVIEW PEOPLE IN

REFERENCE TO CASE NUMBER 08-54128. AT APPROXIMATELY 2238 HOURS, I ASKED AR MURDOCK WHAT HAD HAPPENED TONIGHT. HE REPLIED THAT [REDACTED] AND [REDACTED] ARE GETTING MARRIED AND WE WERE HAVING A PARTY TO CELEBRATE. AR MURDOCK WENT ON TO SAY HE WAS THE LEASEE OF SUITE 6 AND THAT [REDACTED] HAD COME AND GOT HIM FROM THE PARTY SAYING THERE WAS A PROBLEM. WHEN HE (MURDOCK) CAME OUT, HE SAW [REDACTED] (WHICH IS AR FROM THE ASSAULT IN CASE NUMBER 08-54128) WAS BEING TAKEN INTO CUSTODY BY SECURITY.

I ASKED AR MURDOCK TO SIT TIGHT SO THAT I COULD CONCLUDE MY INTERVIEWS WITH INVOLVED PARTIES. I LEFT HIM THERE IN THE SEAT, UNHANDCUFFED AND RETURNED TO VI [REDACTED] I ASKED VI IF SHE WANTED TO PRESS CHARGES FOR SEXUAL BATTERY. VI SAID, "IF I DO, WHAT HAPPENS TO ME?" "I'M SCARED OF WHAT HE DOES FOR A LIVING." THE VI ASKED ME, "DOES THAT GIVE HIM THE RIGHT TO DO WHAT HE DID?" I EXPLAINED TO THE VI THAT IF IT WAS CONSENTUAL; BUT IF IT WAS NON-CONSENTUAL HE DOES NOT HAVE THAT RIGHT.

VI REQUESTED TIME TO THINK ABOUT IT. AT THIS TIME, LT. MILLER TOOK PHOTOS OF VI'S NECK AND A GENERAL ID PHOTOGRAPH. I ASKED VI IF SHE KNEW IF THERE WERE ANY VISIBLE SIGNS OR MARKS ON HER BREASTS. VI SAID SHE COULDN'T TELL BUT WANTED A FEMALE FRIEND OF HER'S THAT JUST SHOWED UP TO LOOK AND MAKE SURE. LT. MILLER AND I FELT THIS WAS MORE APPROPRIATE THAN HER SHOWING US. A FEW MINUTES LATER HER FRIEND ADVISED ME THAT THERE WASN'T ANYTHING THAT WOULD SHOW UP ON CAMERA. VI THEN TOLD ME THAT EVEN THOUGH THEY WILL QUESTION HER CHARACTER THAT DOESN'T GIVE HIM THE RIGHT TO DO WHAT HE DID AND SHE WOULD PRESS CHARGES.

AT APPROXIMATELY 2335 HOURS VI WALKED OUT IN THE HALLWAY AND IDENTIFIED AR. VI SAID, "YEP THAT'S HIM". IT SHOULD BE NOTED AR WAS WEARING A WHITE POLO SHIRT, WAS NOT WEARING A WEDDING RING, AND FIT ALL GENERAL DESCRIPTORS THAT VI HAD GIVEN TO ME. I WALKED UP TO MURDOCK AT APPROXIMATELY 2345 HOURS AND TOLD HIM I WAS PLACING HIM UNDER ARREST FOR SEXUAL BATTERY. AS I CUFFED AR, I EXPLAINED TO HIM THAT HE WAS IN CUSTODY NOW, THAT I HAD NO FURTHER QUESTIONS FOR HIM; AND BASED ON HIS TITLE THAT HE KNOWS MIRANDA AND HIS RIGHTS.

AR MURDOCK STATED, "YES SIR, I UNDERSTAND." HE SLIGHTLY SHOOK HIS HEAD, "I CAN'T BELIEVE THIS", THEN FULLY COOPERATED WITH THIS OFFICER. I ESCORTED HIM DOWNSTAIRS TO MY PATROL CAR WHERE HE WAS UNHANDCUFFED AND PLACED IN THE BACK SEAT OF MY PATROL CAR. AR HAD ASKED ME IF HE COULD MAKE A PHONE CALL SINCE HIS CELL PHONE BATTERY WAS DEAD. I TOLD HIM I WOULD CALL SOMEONE AND GIVE THEM THE BASIC INFO THAT HE REQUESTED FOR ME TO GIVE THEM.

I TRANSPORTED AR TO THE OKLAHOMA COUNTY JAIL, WHERE IN THE PARKING LOT, HE
